365 Days of Eligibility

The board of directors extended 365 days of eligibility to new and current members. This initiative is set to expire August 1, 2023.

There has never been a better time to join the BR&CF. Enhanced days of eligibility coupled with the lowest dues in the industry results in the best value in job income protection. Please speak with your fellow coworkers about this limited time opportunity. A simple referral can earn you \$250.00.

Text an Application

The "Text an Application" feature is proving to be very popular. This feature allows a member to text a coworker a link to a membership application that has the referring member's name and member number automatically inserted in the referral section. This ensures the referring member receives credit for the referral. So far in 2023, ninety-two percent (92%) of approved applications listed a referring member. By comparison, from 2013 through 2022 the percentage of applications received that listed a referring member averaged just forty-seven percent (47%). 180 An incident that causes a second revocation of certification within a twenty-four (24) month period can result in a 180-day revocation of your engineer or conductor certificate.

Annual Meeting of the Members

The 2023 annual meeting of the members was held April 22, 2023, at the principal office in Mechanicsburg, Pennsylvania in accordance with the provision of Article XX of the BR&CF Constitution. Thank you to each BR&CF member who exercised their proxy to ensure a quorum of the membership was achieved. The BR&CF board of directors welcomed members from across the U.S. and Canada. The officers gave presentations that addressed last year's dues reduction, 365 days of benefit eligibility, the current discipline environment, progress made on various information technology projects, general and administrative cost reductions, and member service.

Three board of director positions stood for election: D. J. Despines, Jr. was reelected to a 5-year term as Assistant International President; B. J. Penfield was reelected to a 5-year term as International Secretary-Treasurer; and B. W. Plant was reelected to a 5-year term as Assistant International Secretary-Treasurer.
